5. The students who intend to file nominations shall strictly comply with the Clause 8 (i) of the ordinance.

6. The Class Representatives Elections in DIPSAR and DPSRU, shall be conducted under the supervision of *Dr.S. K. Wakode, Professor, DIPSAR & Dr. Sushma Talegaonkar, Associate Professor, DPSRU, respectively.*
7. *Dr. Rajiv Tonk, Associate Professor, DPSRU, has been nominated as the Patron for the DPSR University Students Council and Sh. Ankit Goel, Section Officer (LAW), DPSRU, has been nominated as Returning Officer (RO) for the elections.*
