All the criteria were discussed in detail and the respective Incharges presented their work.

The items like Programme code for various programmes run by the University, CBCS system, open electives, syllabus revision and academic flexibility have been discussed. It was suggested by Hon'ble VC that all the programmes like B. Pharm, M. Pharm, PhD, Physiotherapy, Management and ASSRM has been covered while preparing for the NAAC accreditation.

Also, the points like separate classes for medium and slow learners, remedial classes, ICT facility, mentor-mentee system, examination reforms, examination and library automation has been discussed. The creation of research policy, IT policy of University, creation of media center, lecture center and e-content development by the teachers, students benefitted by the scholarships, alumni connect and support for competitive exams has been discussed. Hon'ble VC sir has given useful suggestions and explained that how the University is working on strengthen ICT facility and automation. The mentor-mentee system, and the process of automation has already initiated by the University.
